An exception to the MedX Warranty is battery components - warranty is 12 months from the date of manufacture, which is clearly marked on the battery. A service representative will create a return authorization (RMA) number for you to submit with the returned unit. MedX Electronics Inc. shall not be responsible for any shipping, custom fees, taxes, or VAT that may be due.

All repairs must be performed by MedX Electronics Inc. or an authorized service center or dealer. Any modifications or repairs performed by unauthorized centers or groups will void this warranty. When directed, please send to MedX Electronics Inc., 220 Superior Boulevard, Mississauga, ON L5T 2L2. Please package your unit carefully in its original box and packing material to avoid damage in transit. MedX is not responsible for any damage caused to the unit in shipment.

This warranty is only valid if the unit is used solely for purposes in accordance with the instructions. This warranty is void if the unit is connected to an unsuitable electrical supply, or dismantled or interfered with in any way or damaged through misuse.
